

WHEREAS, in compliance of the directions at Para 140(1)(ii) read with Para 140 (1) (vii) passed by the Hon'ble Gauhati High Court dated 20/06/2025, in W.A. 154/2020 (Shri Jyotirmoy Adhikary Vs State of Assam and Ors.) and other linked cases, the Governor of Assam is pleased to withdraw the Government order of discharging Shri Jyotirmoy Adhikary, recruited as Labour Inspector (under suspension), under Assam Labour Services through Combined Competitive Examination for ACS and other Allied Service Officers, 2013 vide Notification No.GLR.169/2017/Pt/18, dated Dispur the 7th July, 2018;

AND WHEREAS, as directed by the Hon'ble Gauhati High Court, the case of Shri Jyotirmoy Adhikary, who **was on probation** as Labour Inspector (under suspension) under Assam Labour Services at the time of discharge vide Notification No. GLR.169/2017/Pt/18, dated Dispur the 7th July, 2018, is considered and upon consideration he is not found fit for confirmation and being a member of the Assam Labour Services;

NOW THEREFORE, the Governor of Assam, in exercise of the powers conferred under Rule 13 (c) of the "Assam Labour Service Rules, 1970", is pleased to discharge Shri Jyotirmoy Adhikary, as Labour Inspector (Probationer under suspension) from Assam Labour Services with effect from 07/07/2018, that is the date of discharge given vide Notification No. GLR.169/2017/Pt/18, which stands substituted as directed by the Hon'ble Gauhati High Court.
